Wastewater Division August 2023 Statistics

- Average Influent flow 97.31 mgd
- Average Effluent TSS -11 mg/l
- Average Effluent BOD 10 mg/l
- Biosolids production –During May MCUA produced 12,634 wet tons of filter cake, all of which was processed through the dryers resulting in 4,774 wet tons of class A product; and 223 class B product.
- *Rainfall for the month was 5.59 inches as measured at the Treatment Plant.
